PROPOSED CHANGES PRESENT A TURNING POINT FOR AAUW

AAUW has advanced through profound turning points, beginning with the 2005 Strategic Process, powered by member support for change. At Convention 2007, members unanimously endorsed the new directions indicated by this restructuring and charged the Bylaws Committee with proposing bylaws that would align new structure and

governance with the intent of the Strategic Process.

The **draft proposed bylaws** present yet another positive challenge, another turning point for its member community – either to consider and support what needs to be done in refocusing AAUW, or to stand by past practices. Members are asked to consider new ways of achieving our mission in an ever-changing sociological, economic, political and technological environment. I will try to summarize some of the proposed changes as well as the rationale advanced by the Bylaws Committee.

The bylaws draft is being reviewed by members across the country, and following further revision, will be presented to the Association/EF boards at their October meeting. The proposed bylaws will then be published in the *AAUW Spring Outlook*, before debate and voting at Convention 2009. The tight timeframe necessitated member feedback at www.aauw.org, Member Center, Strategic Process, by August 30.

Several proposed articles directly impact states and branches. Purposes are to facilitate greater flexibility in structure, provide members with multiple ways to participate in AAUW, and create closer linkages between members and national AAUW. Members can determine whether or not there will be a **state structure**, or can establish a structure among states. The only requirements would be to further AAUW's purposes and program, and to designate an administrative contact within the area.

To promote AAUW mission, **branches** may create any leadership structure that meets their needs, provided there is an administrative and a financial contact. Branches must have basic bylaws and will continue to be officially approved through AAUW. A branch may be geographically based or may be an online branch not tied to a geographical area. If there is a state or interstate structure, all branches within that structure will be automatically affiliated.

There are no provisions for the continuation of geographic **regions** as currently exist, so these entities would end. However, geographic areas or combinations of states would be other options for advancing mission-based program. It is being considered that the role of regional director will evolve into field staff positions and trained volunteers who will work directly with members.

The greatest proposed change is the composition of **membership**. "Any individual or institution who supports the purpose and mission of AAUW may become a member of AAUW." This is a natural outcome of our mission and our Value Promise – By joining AAUW, we belong to a community that breaks through educational and economic barriers so that all women have a fair chance. An educational requirement can be discriminatory on the basis of income, class and ethnicity. AAUW cannot claim to break through barriers on behalf of all women if not all women and men can join in its work. This move toward more open membership has been evolving through recent conventions and has gained increasing groundswell support.

Certainly there will be much debate about many aspects of the draft proposed bylaws. The Bylaws Committee invested over a thousand hours in considering many data points within the context of the strategic process as they crafted this draft. AAUW Gains Special Consultative Status with U.N.

AAUW has gained special consultative status at the United Nations with the Economic and Social Council (ECOSOC), which initiates reports, makes recommendations, and promotes respect for human rights and fundamental freedoms.

For many years, AAUW has had a U.N. representative attending select meetings and monitoring issues affecting women and girls. The new designation allows AAUW to participate in international conferences, sign on to NGO statements, and share AAUW's expertise.

"We closely follow a variety of international issues ranging from girls' education to women's economic security to human rights to women in peacekeeping," said AAUW Executive Director Linda D. Hallman, CAE. "This new status will strengthen AAUW's presence globally and provide us with greater opportunities to engage in U.N.-related activities and initiatives that break through barriers for women and girls."

AAUW has a proud history in global affairs that includes awarding more than 2,200 international fellowships to women from more than 130 countries and partnering with leading international humanitarian organizations on initiatives to empower women.

Next year, AAUW will actively advocate for women at the 53rd session of the U.N. Commission on the Status of Women, which will focus on the equal sharing of responsibilities between women and men, including caregiving in the context of HIV/AIDS.

"AAUW can now advocate more effectively and support policies aimed at strengthening gender equality, especially in the areas of the economic, social, political, and reproductive health rights of women and girls," said Carolyn Donovan, AAUW's U.N. representative.

Currently, AAUW is encouraging its branches to commemorate the 60th anniversary of the Universal Declaration of Human Rights on December 10 and to continue supporting ratification of the women's rights treaty—the Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW).

"AAUW members have long supported our efforts, from hosting international visitors to initiating forums and symposia on global issues pertinent to women and girls," said Gloria L. Blackwell, AAUW's director of fellowships, grants, and international programs. "We are thrilled that our role is expanding."

Membership Matters

Membership Categories

Members of Branch (MOB)

A graduate holding an associate or equivalent, baccalaureate, or higher

degree from a qualified educational institution shall be granted membership upon payment of dues to the AAUW branch treasurer.

- * New MOBs are those who have no current AAUW affiliation.
- * Former AAUW members who have not renewed their membership within the last two years are categorized as new members. Previous years however count toward 50-year honorary life membership.

Dual Members

"Any AAUW or associate member who holds membership in more than one branch is referred to as a dual member."

- * Dual members pay Association, State, and branch fees through their primary branch and only branch fees to their secondary branch.
- * If the primary and secondary branches are in different states, secondary states may also require the dual member pay dues and fees.
- * Dual members are included in the Feb. 1 count for all branches.
- * For the AAUW convention, dual members are included in the delegate count only for their primary branch.
- * Dual members can hold any office but president in their secondary branches.

Paid Life Members (MBL)

Any member may become a paid life member of the Association upon payment of the current Association dues multiplied by 20.

- * MBLs are exempt from further payment of Association dues.
- * MBLs pay branch and state dues as established by the branch and state.
- * MBLs receive a confirmation congratulatory letter, certificate, and permanent membership card.

Honorary or 50-Year Life Members (MBHL)

Any member who has paid Association dues for a total of 50 years is eligible for honorary life membership. The 50 years need not be consecutive.

Membership continued

- * The member or the member's branch **must** submit the application for honorary life membership.
- * MBHLs upon recognition are exempt from further payment of Association dues.
- * MBHLs must pay branch and state dues, unless the branch or state chooses to waive dues for those members.
- * MBHLs receive a confirmation congratulatory letter, certificate, and permanent membership card.

Members-at-Large (MAL)

MALs are not affiliated with any branch and pay dues directly to the Association and only receive *AAUW Outlook* and all Association services.

* MALs can transfer to branch membership at any time, in most cases without paying additional Association dues.

A Message from the State Finance Chair Ginny Giordano

A reminder to all finance chairs and members of AAUW:

Association (\$49) and state (\$15) dues were payable on July 1. (Along with your branch dues.) Many individuals and branches have all ready submitted dues for the 2008-2009 year.

Association memberships will be processed within two weeks of dues check clearance.

After November 30, all non-renewed members will be removed from the branch roster. Finance chairs should check their rosters on the Association website and individuals should check their own listing. If you have any questions on accessing the rosters please contact me. Please email <code>Helpline@aauw.org</code> with any discrepancies.

Branch Finance Chairs should have received a mailing form the Association regarding a new IRS Reporting requirement- 990 N. This is required even for branches whose gross receipts are under \$25,000. If there are questions regarding this please feel free to contact me at <code>ggio@verizon.net</code>

Educational Foundation

The Educational Foundation (EF) is a cornerstone of AAUW and is often something we members brag about when telling people about AAUW. There have been shifts in the organizational structure of AAUW, EF, and the Legal Advocacy Fund but they haven't changed EF's mission or its importance. Its mission

remains:

The AAUW Educational Foundation provides funds to advance education, research, and self-development for women and to foster equity and positive societal change.

I'd like to remind everyone that our EF Year is shifting to match that of the Association: January 1 -December 31. Over the years there has been much confusion in trying to reconcile reports from DC with that of AAUW-MA and figuring out what counts for what year (I know because I was the Bedford-Lexington Area Branch EF Chair for a few years). Now it will be simple: paid in 2008 counts for 2008. In our recognition of branches and individuals at the next AAUW-MA convention, we will be using the 2008 numbers which will include some overlap since the April 2008 state convention was using the spring-tospring numbers. Lucky you if you made a contribution in the early part of 2008 - it will be counted twice for recognition purposes! If anyone is confused by all this, feel free to contact me.

I'm hoping every member will make a contribution to the best of their ability as even the small ones are important – percentage counts towards commitment as well as total dollars. I have neither the time nor inclination to run a fundraiser at the state level (other than, perhaps, a raffle at convention) so my pestering will be straight-forward: please help Massachusetts have 100% participation to help AAUW-EF forward its mission.

There is an important administrative point I'd like to emphasize – when writing a check intended for EF, make it out to AAUW-EF <u>not</u> to your branch. It will make your branch EF chair's job easier – or mine if the check is coming directly to me – and will avoid the necessity of having you write out a new check. Checks to AAUW-EF (and AAUW-LAF) are tax deductible; those to branches are not. The following is from the toolkit for EF Chairs and is worth sharing with everyone:

SUBMITTING CONTRIBUTIONS

To protect donors from audit and tax problems, branch and state EF chairs should submit

directly, without processing (cashing or depositing) these contributions in their own branch and state accounts. In other words, for the most part you will accept checks for the Foundation, but not process those checks. Instead, you will send those checks directly to the Foundation. Donors' checks should be made payable to the AAUW Educational Foundation. Be sure to indicate the donor's name and the name of the branch and state for proper recognition and credit. Send contributions along with a Foundation contribution report form, available from the Foundation's fax-on-demand service at 888/603-7116 or the Member Center on AAUW's website. Detailed instructions accompany the form. State EF chairs send out all necessary information, including deadlines, to meet the Jan. 31 deadline. Contributions submitted to the Foundation will be acknowledged with an official tax receipt sent directly to the donor. While branch and state acknowledgments, such as thank-you letters, may be a good way to cultivate donors, branches and states cannot provide the donor with a receipt recognized by the IRS. The Foundation will provide that receipt.

Legal Advocacy Fund

From the **Summer LAF UPDATE**:

When the AAUW Legal Advocacy Fund began in the 1980s, its purpose was to encourage AAUW members to invest in activities that would prevent sex discrimination and promote gender equity in academia. This year, as part of our Strategic Process, the AAUW and AAUW Educational Foundation boards approved the expansion of LAF case support to align more closely with our Value Promise to

break through educational and economic barriers so that all women have a fair chance. This means that, going forward, the generous donations of our members will be available to help women in all workplaces, not just in academia. Our intent is to focus on strategic litigation. Instead of responding to applications for support, we are working proactively with a number of civil and women's rights organizations to identify litigation that has strong potential for establishing precedent or making some other significant contribution to advancing equity or reducing discriminatory workplace practices. Plaintiffs selected for support by LAF will continue to be available to travel to visit branches. Likewise, we will continue supporting campus outreach programs and expanding our online LAF resource library to include more topics on discrimination in the wider workplace.

LAF currently supports eight lawsuits.

This spring, the AAUW Educational Foundation Board of Directors voted to move the direction of LAF's case support away from direct plaintiff support toward support of cases that will have national significance for women in all workplaces. Therefore, while we have continued to work with our current plaintiffs, no new cases have been adopted since this decision.

Pending Cases

Ilon v. The State University of New York, Buffalo, et al.

A hearing took place in April, and the judge ruled in favor of the defendants. Ilon's attorney may file a motion for a new trial.

Jaureguito v. Feather River Community College Thein v. Feather River

Community College Wartluft v. Feather River Community College

Feather River College recently filed motions in both state and federal courts to stay all proceedings until such time that the California State Personnel Board could render a decision on Thein, Wartluft, and Jaureguito's whistle-blower claims. No decision has been made by the board. The plaintiffs opposed the college's motions and asked that the Butte County Superior Court set these matters for trial as soon as possible. The Butte County Superior Court is expected to rule in August. The Title IX claims of all three cases are currently set for trial in April 2009 in federal court.

Mansourian, et al. v. Regents of the University of California, et al.

The parties completed a summary judgment briefing in early April 2008. A hearing was held in April, and the court ruled that there was not sufficient notice of discrimination. Mansourian's attorney will file an appeal.

Potera-Haskins v. Gamble, Montana State University, et al.

On September 28, 2007, Potera-Haskins received a partial victory in her case. Although the court dismissed her Title VII claims, it allowed her Title IX claims to move forward. A trial date was set for February 1, 2008; however, in early December 2007, the district court unexpectedly vacated the trial date without explanation and stated that a new trial date would be set in the future after retrial evidentiary motions are heard and ruled upon. A new trial is set for October 20, 2008.

Settlements and Decisions

Schuster v. Berea College

Schuster's attorney filed her motion for appeal in September 2007. In March 2008, a three-judge panel was seated to review and rule on the appeal. They began their review and deliberations in May 2008, and ruled in Schuster's favor in August 2008.

Doe v. Berry College

Doe, a student at Berry College in Georgia, sued the college for sexual harassment and assault in violation of Title IX of the Education Amendments of 1972 and other claims in violation of Georgia state law. In December 2007, the federal court dismissed Doe's claims against Berry College without prejudice.

Brodsky v. Kaleida Health and State University of New York at Buffalo

Brodsky, a medical doctor and tenured full professor at SUNY-Buffalo, sued the university for pay discrimination and retaliation in violation of Title VII and the Equal Pay Act. Brodsky filed suit in federal district court in September 2001. In May 2008, Brodsky settled her case with SUNY-Buffalo and resolved all related litigation.

Chichilnisky v. Columbia University

Chichilnisky, professor of statistics at Columbia University and UNESCO professor of math and economics, sued the university for pay discrimination, retaliation, and breach of settlement agreement in violation of New York state laws in 2000. On June 26, 2008, after a 10-day trial, Chichilnisky settled with Columbia University for an undisclosed amount.
