## LEGAL ADVOCACY UPDATE

#### **Case Support**

In late May, the Educational Foundation board voted to divide \$18,000 in funding between the five current Legal Advocacy Fund-supported plaintiffs:

### **Amicus Brief**

On June 5, 2009, AAUW joined the National Partnership for Women & Families in signing an amicus brief to be filed with the U.S. 4th Circuit Court of Appeals in the sexual harassment case Harris v. Mayor and City Council of Baltimore City. Harris says that she encountered persistent harassment in her job at the Baltimore Department of Public Works, including being called "b---h" and being forced to sit at a table covered in pornographic images of women. The district court awarded summary judgment to the city, finding that the treatment

Harris endured was not perpetrated "because of sex" and was not sufficiently severe or pervasive.

The amicus brief argues that the district court improperly discounted evidence that harassment was directed at Harris, and that, in any case, actions not specifically directed at a plaintiff should be considered in determining whether sexual harassment meets the standard of severe or pervasive. Further, it argues that displays of pornography and use of epithets like "b\_\_\_h" are inherently gendermotivated harassment.

#### Sexual Assault on Campus

**Project**: LAF is crafting a manual and a Program in a Box focused on campus sexual assault policies in collaboration with the AAUW Research Department, Harvard University Law Professor and Title IX expert Diane Rosenfeld, her students, and Students Active for Ending Rape. The materials will be released in fall 2009.

# Title IX in High School

Athletics Project: In collaboration with the AAUW Research Department and the Legal Aid Society of San Francisco, LAF plans to release a new tool kit and Program in a Box in the fall on Title IX enforcement in high school athletics. These materials will focus on the rights of girl athletes and how schools can and should be approached to ensure title IX implementation and enforcement.

The following principles provide a basis for AAUW members' actions at the local, state, national, and international levels. Implicit in each of our principles is support for government agencies administering programs, including adequate appropriations, effective and accountable administration, and provision for citizen participation. We advocate public discussion to ensure enlightened decisions on these principles. We work to increase the number of underrepresented populations, including women, in policy- and other decisionmaking positions. AAUW is committed to working in partnership with diverse allies and coalitions to break through educational and economic barriers for women and girls.

# SETTING THE RECORD STRAIGHT

AAUW's Executive Director, Linda Hallman, has sent the following statement to all state and branch Public Policy chairs:

"AAUW has been victimized by an act of blatant fraud...An agent of Bonner & Associates, through its work with the American Coalition for CleanCoal Electricity, has forged one or more letters from AAUW to members of Congress. Other well-known organizations were similarly targeted, and the goal was to further the coal industry's lobbying efforts against the Clean Energy and Security Act..."

Interestingly, Ms. Hallman points out that energy policy is not a topic on which AAUW advocates, but we are best known for playing a role in some of the greatest success stories in the areas of pay equity, familyfriendly workplaces, and education. Hallman also notes its sympathy with other organizations having been portrayed in a false light, and supports Rep. Edward Markey's (D-MA) investigation into this matter.

#### SAVE THE DATE!

DID YOU KNOW...

The Coalition for Choice, of which AAUW is a longtime member along with many other organizations, plans a Lobby Day at the State House for Tuesday, October 6, from about 10 a.m.--2 p.m., and I plan to attend. Please consider joining me (I'm taking the bus to Alewife and the T to Park Street, an easy trip).

We'll be lobbying our representatives and senators at the Great and General Court, asking for their support on prochoice bills (and opposition to antichoice ones). If you have not been living on Mars then you know that women's rights can never be taken for granted. More on the specific bills we have been following will be in the October bulletin. ...that President Obama, in Women's History month (March, 2009), named Valerie Jarrett to head a White House panel to advise him on issues facing women and girls? This council is designed to help Cabinet agencies and departments collaborate on ways to make sure women are provided opportunities offered to men. Upon signing the Executive Order, he commented that "the fight for gender equality is far from over," and cited pay disparities, domestic violence, and the relatively few women in Congress and in the executive offices of major companies.
