Breaking Through Barriers for Women and Girls

PANEL DISCUSSING: "POST-MORTEM ON THE 2012 ELECTIONS" BEDFORD PUBLIC LIBRARY 7:00 PM, NOVEMBER 7, 2012

The day after the 2012 presidential and state elections, the branch is sponsoring an exploration of the national, international, and local implications of election outcomes. Our conversation will be initiated by a panel of knowledgeable political commentators: Martin Kilson, Professor of Government *Emeritus* at Harvard University; Janet Vaillant, member of the Davis Center for Russian and Eurasian Studies at Harvard University; and Lois Pulliam, Bedford-Lexington Area Branch AAUW public policy co-chair. Professor Kilson, whose analyses of the 2008 presidential election appeared on *BlackCommentator.com* and in Charles Henry's *The Obama Phenomenon: Towards a Multiracial Democracy*, will focus on the presidential election and what its outcome portends for the nation. Dr. Vaillant will comment on the connections between internal politics and foreign policy, emphasizing expected continuities and changes based on the election outcome. Ms. Pulliam will explore the potential impact of the national and state elections on AAUW's key public policy issues, including pay equity and reproductive choice. After the panelists' presentations, branch members and guests will have an opportunity to join the discussion.

GENDER BIAS BY SCIENCE FACULTY?? Article review by Ruth Ladd

Research by five Yale professors, and edited by a Princeton professor, shows that, yes, both male and female science professors are biased against female students! This is written up in a new article approved on August 21, 2012 by the *Proceedings of the National Academy of Sciences* (http://www.pnas.org/content/early/2012/09/14/1211286109). The article is entitled, *Science faculty's subtle gender biases favor male students*.

The article reports that there are more women receiving science degrees than in the past but the percentage of female Ph.D.s and junior faculty is much lower than would be expected based on the number of graduates. Much research has been done looking at life choices, self-chosen or not, by women which probably does play a role in the numbers but there has been an assumption that there is no discrimination from biological and physical science faculty once a woman is in the university system. These authors decided to see if this assumption is accurate.

A double-blind study was conducted which gave resumes from male and female students for a laboratory manager position to 127 biology, chemistry, and physics faculty from public and private universities with a focus on research. The faculty thought this was a real situation where their decision and recommendations would influence hiring and benefits such as salary and that they would be providing any mentoring offered. The resumes were identical but half used John and half Jennifer. Faculty rated "John" as significantly more "hireable" and competent for the position. They also recommended higher salaries (average of just over \$30,000 for men and \$26,500 for women) and more mentoring to "John." The article's graph (Figure 1) showing these differences is quite dramatic. The gender of the faculty member did not affect the ratings and recommendations!

An effort was made to determine the key reason for the disparity and it appears that there is some bias against support for female students as opposed to bias for support of male students. The authors conclude that institutions need to address the bias, which appears to be unintentional, against female students to increase the participation of women in science.

LAF CASE

Klay et al v. Panetta et al.

Case Adopted 03/12

Background: Ariana Klay is one of eight plaintiffs suing the U.S. military for allegedly creating a culture in which sexual assault and rape are tolerated and in which people who report it face retaliation.

Klay says she was raped by a fellow officer and his friend while she was stationed at the U.S. Marine Barracks in Washington, D.C. Klay says that after she reported it, she was accused of inviting the attack by wearing makeup and her regulation-length skirt. One of the rapists was court-martialed but, as often happens in the cases of reported rapes, was convicted of a lesser crime: adultery and indecent language.

Klay and the other seven plaintiffs allege that U.S. military officials tolerate sexual predators in their ranks and antagonize service members who report rape, sexual assault, and harassment. The plaintiffs say that this culture of sexual assault violates their constitutional rights.

The case was filed on March 6, 2012, in the District of Columbia by lawyer Susan Burke. AAUW Executive Director Linda D. Hallman spoke at the National Press Club event and emphasized AAUW's deep concerns about an apparent pattern of sexual assault in the military and reminded the audience of a similar case that AAUW is also supporting, Cioca v. Rumsfeld, also filed by Susan Burke and centered on the issue of sexual assault in the military.

Burke and several of the plaintiffs from both cases, including the named plaintiff, Ariana Klay, are featured in The Invisible War, a documentary about sexual assault in the military. The documentary premiered at the Sundance Film Festival in Utah in January 2012 and won the Audience Award.

Elizabeth Warren's supporters. We were considered a political group though non-partisan - because we were doing voter registration. It was a tremendous success because we did voter registration under the guidance of Becca, so many people were at the fair, and it was a social occasion for us (a wonderful chance to chat!).
