Great news!! The Massachusetts Senate passes The Early Education and Child Care Bill!

On March 15, the Senate unanimously passed An Act providing affordable and

accessible high quality early education and care to promote child development and well-being and support the economy in the Commonwealth.

The legislation will help to reduce the high costs of child care and early education in the state and make high quality child care more accessible and affordable for families. "This would help families afford child care and give them the freedom to go back to work if they want to. We know there's a workforce shortage in Massachusetts, let us get parents back to work who want to go back to work. But we need to give them to child care first," State Senate President Spilka said.

The bill puts in place a plan to spend \$1.5 billion that the Legislature already set aside in the fiscal year 2024 budget for early education and care initiatives. It makes permanent a grant program — Commonwealth Cares for Children — to provide money to more than 90% of early education and care programs in the state.

It increases eligibility for child care to families making up to 85% of the state median income, which is \$124,000 for a family of four. A matching grant program will encourage employer investment in increasing early education and child care capacity. Recommended salary and benefit guidelines will be established that are in line with public school teachers. Department of Higher Education scholarship and loan forgiveness programs will be made permanent under the bill.
