Gabrielle Jackson, an Eastern Regional Commissioner, from the MA Commission on the Status of Women (MCSW) will join us to share information about the MCSW. The mission

of the Massachusetts Commission on the Status of Women (MCSW) is to advance women toward full equality in all areas and to promote rights and opportunities for all women. The Commission exists to provide a permanent, effective voice for women and girls across Massachusetts, and represents fundamental freedoms, basic rights, and the full enjoyment of life for all throughout their lives. There are eleven county and regional commissions and each regional commission consists of 9-13 persons who are appointed by the MCSWto a 1-3 initial term. As part of their mission they run several programs to promote rights and opportunities for all women and girls across Massachusetts such as Commonwealth Heroines, Girls Empowerment Leadership, Advocacy Day, and Speakers Bureau. As you can see their mission and programs align nicely with AAUW's, so I hope you'll join the Zoom meeting on Tuesday, March 11th to hear more about this organization. #### **REFOCUS, RETHINK, REGROUP TO MOVE FORWARD**

Gloria Blackwell: AAUW Chief Executive Officer

- Spoke on the Trump administrations ruling on Title IX: "Direct attack on students nationwide...more difficult for most vulnerable students to report their harassment and seek protection"
- Economic stability is in danger. We must work to "shape a future where equity is reality"
- We must support women to get higher education. Economic empowerment is critical. Important for women to get the skills that lead to financial independence.
- AAUW has given out Fellowships and Grants of \$6.3 million to 261 women (3K applicants).

#### Meghan Kissell: AAUW Senior Director of Policy and Member Advocacy

- Spoke about the 119<sup>th</sup> Congress and the Anti-transgender bill, 50+ Executive orders already passed by the new administration
- AAUW has to increase visibility. Working on FMLA job protections for unpaid leave, redefining gender, curriculum control, vouchers at state level, DEI, etc.

The Massachusetts Commission on the Status of Women (MCSW) is a state-established body charged with reviewing the status of women in Massachusetts and offering recommendations regarding policy that would improve access to opportunities and equality.

The Commission recognizes the need for women to gain not only an equal share, but become equal participants in the areas of economics, health-care, civil rights, education and business development. The MCSW shares many broad objectives with AAUW.

Plymouth County is among the eleven Regional Commissions throughout the state.

Advocacy Day is an event held every other year by the Massachusetts Commission on the Status of Women (MCSW) and their partners. They rally at the Massachusetts Statehouse and visit legislators to promote legislation that advances the rights and opportunities of women and girls across the Commonwealth.
