## Public Policy

**Some Washington Updates on National Legislation, a Supreme Court case, and more.**

**Supreme Court case Louisiana v. Callais** – a Louisiana-based challenge to key aspects of Section 2 of the Voting Rights Act, which prevents racial discrimination in voting. Severe ramifications for the country if overturned.

**Safeguard American Voter Eligibility (SAVE) Act.** The United States House of Representatives has passed the SAVE Act (HR 22), which would require every eligible voter to provide documentary proof of citizenship to register to vote. Concern is that this can lead to voter suppression—and disproportionately impact women. AAUW formally opposes the SAVE Act.

representatives and senators to champion passage of the John Lewis Voting Rights Advancement Act (HR 14), supported by AAUW

**Opposing the Higher-Ed “Compact”.** The administration’s “Compact for Academic Excellence” ties funding to rollbacks of DEI and academic freedom. AAUW will issue our own statement, and we’ve joined a coalition letter urging presidents and trustees to reject the “administration’s invitation to violate the law, abdicate your duty to your students and campus community, and betray academic freedom.” MIT and Brown University have both publicly rejected the Compact.

AAUW has submitted an organizational comment opposing the **U.S. Department of Education’s proposal to adopt the supplemental priority “Promoting Patriotic Education.”**

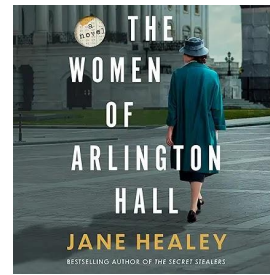
